**REMARKS**

Upon unanimous consent request of Representative Johnson, the remarks made by Pastor David McAllister on Thursday, March 24, 2011, were ordered printed in full as follows:

“Good morning and thank you, this has been one of the greatest joys of my life. I’ve had a blast being here. I know that may not be a good ‘etiquette’ term, but I’ve had a blast. I have felt like a kid in a candy store. It’s been a thorough honor to serve you. I appreciate you letting me be here and I so much appreciate Representative Dennis Johnson for trusting me on your reputation with this honor. I hope I have honored you as much as you have honored me.

I would like to introduce my wife, Angie who is seated in the gallery with my daughter, Rachel. I also would like to introduce my son, Joshua who has also had the privilege to serve as a page this same week so we have had a double honor. You have been such a blessing to my family and I appreciate it so much.

In Deuteronomy 19:14, it says ‘thou shalt not remove thy neighbor’s landmark, which they of old time have set in thine inheritance, which thou shalt inherit in the land that the LORD thy God giveth thee to possess it.’

Biblically and literally, this says not to remove landmarks set from the territories that God gave them; they marked their territories that God gave them as the promised land to each tribe. Theologically, it tells us not to remove ancient landmarks for they are the doctrines and foundation in Christ found in scripture; where we came from and how we are to establish ourselves. Today, don’t forget where we came from as a people and a nation. Remember those who have fought and died for our freedoms to bring us where we are today. Remember those who served in this office before us.

A little before this in Chapter 6, Israel was given the great Shema; one Lord, one soul and mind. Teach your children; when you rise up, walk in the way; when you sit down to eat; put it on the door post, everywhere it could be seen. They were told to do this so that when you come into the land you didn’t earn, you will remember that it was the Lord God who brought you here today.

Forty-eight (48) years ago, in 1963, a war was raging over whether or not to remove prayer and the Bible from public schools. It was a veracious thing. There stood a chaplain here in 1963, a tall slender man, about 6’4”; a meek and gentle man and a fireball of a Pastor. His name was Albert N. Glasgow of Emanuel Baptist Church in Wagoner, Oklahoma. His words were not recorded but knowing the battle they were facing, he may have said something like this to the House; don’t give up, don’t quit, don’t back down. Remember who you are and where you came from. Remember the men and women who came before you and stand on their shoulders so you can see from their vantage point so you can see what could be and what should be. Don’t back down from the scripture. Remember we are founded on the scripture. Don’t be afraid of the opposition. Stand for God and stay true.

You might say, well that’s a pretty healthy extrapolation from nothing in the journal until now. I don’t think so. You see, Albert N. Glasgow was my grandfather and I knew him well. He was my mentor, my teacher and an example of what it meant to be a child or man of God and a Pastor and a preacher. I say to us today, don’t back down. Don’t quit, don’t turn from God. Remember where you came from, remember those who stood before you and stand on their shoulders so you can see what could be and should be. Our nation was founded upon the principles of the word of God. God put you here for this time and this hour.

I know that the bills you face are difficult and things you have to deal with are heart wrenching. I know it is often hard to decide which way to go. Base it on the Bible. Stand true to who you are. God is the one who established this not us. I want to remind you that if you are serving God in this place, God is supporting you in this place. I’m reminded of the history of Israel, the day when leaders of Israel abandoned God. Israel was taken captive by Assyria. Judah was taken captive by Babylon. God told Jeremiah to prophesy all things taking place and in Jeremiah 13, he says, I say unto the king and queen, humble yourselves, sit down; principalities (meaning your prestige) shall come down, even the crown of your glory. Cities of the south shall be shut up and none of them shall open. Judah shall be carried away captive all of it, it shall be wholly, carried away captive. Lift up your eyes. God asked the king and queen, where is thy flock that was given thee? Thy beautiful flock. Men and women of the House, your flock is the people of Oklahoma. One day, you will stand in account for how you governed this state. God will ask you, where is your flock? Remember, God is the one who gave you this flock. Serve him and if you

serve him you will serve us in great ways. The state will go on to be a great state. We together can honor God in all that we do. It will be a testimony to the states around us and to the world because we do it the way God said. Thank you so much for your time. One last thought before we pray. If you do not know this God as your personal savior, it is so easy. Put your trust in Jesus Christ. The Gospel by which we are saved is this, Jesus died, was buried and rose again. If you trust that, that is your salvation. If you've not asked him as your personal savior all you have to say is, Jesus, save me, I am a sinner, I put my trust in you. I ask you to forgive me of my sins. Thank you, I pray this is Jesus name. Let us pray:

Dear God, we come before you and one last time I get to be in the presence of these great men and women and I thank you for the joy and privilege. I pray Father that you would bless them mightily. I pray that you would give them strength and freedom in thought and mind, a passion to serve but that their passion would not short circuit their reasoning. Father, give this great body wisdom, let them see what could be and should be and make those decisions that would get us to the place where we could and should be. Father, this is a needed time in our day for these folks to stand. They are facing great difficulties and they need your strength and your grace. You promised Lord that you have more grace than we have problems and now we pray that you wrap your arms of grace around each one. Strengthen them for the battles to come. Give them the ability to stand and to stand with integrity, to stand in honesty and to stand with confidence that you're in charge and you can handle anything that comes. Father, bless their families, give them strength, and we will praise your name and we give you the all the glory and give you honor because you are the only one worthy. In Jesus' name we pray this morning, Amen."
